



Rules and Regulations

The following Rules and Regulations are designed to help ensure that you and your child have a safe and enjoyable experience at My Playground & Truckee Gymnastics. Please read thoroughly, sign and return along with the Authorization, Release and Waiver of Liability Agreement.

1. Have fun!
2. I understand that my child(ren) should participate barefoot for safety and to maximize their gross motor development. Socks are OK for adults. No shoes of any kind are permitted in the studio.
3. No food or drink (except water in a sealed, leak-proof container) allowed in the studio.
4. Although I understand that My Playground & Truckee Gymnastics has attempted to create an injury free play area for my child(ren), a child needs constant attention and I agree to be either personally responsible for providing that attention, or appoint another caregiver to provide that attention.
5. I understand that My Playground & Truckee Gymnastics may compile and use photographs of my child(ren) and me. I consent to such use and hereby waive all rights to compensation.
6. Do not bring your child(ren) if they or you are sick or injured.
7. I understand that I will not allow siblings or other children under my care who are not enrolled in a class to participate in that class, and that I am responsible for ensuring they wait quietly and not disrupt, participate or in any way create an unwelcome or unsafe environment at My Playground & Truckee Gymnastics.
8. I understand that if I designate a caregiver to be with my child, that the caregiver will be required to sign a similar release and waiver before either they or my child may be allowed to participate in class.
9. I understand that My Playground & Truckee Gymnastics will not be held responsible for lost, damaged or stolen property.
10. I understand that if I or my child(ren) damages any equipment or property while at My Playground & Truckee Gymnastics that I will be responsible for paying any necessary repair or replacement costs.
11. I understand that fees are due on my first scheduled class day of each month or session, regardless of whether or not I am able to attend, for that calendar month or session and if I am late, including checks returned unpaid, that I will be charged a \$10 late fee and may forfeit my spot in class to someone else on the waiting list. Fees may be postmarked by the due date to avoid late fees.
12. I agree to pay a \$20 fee for any check that is returned unpaid by my bank or financial institution.
13. We cannot refund fees if your child is absent as these payments hold your child's space at My Playground & Truckee Gymnastics.
14. I agree to provide written notice two weeks in advance of the last class we plan to attend if I wish to withdraw my child(ren) from My Playground & Truckee Gymnastics.
